FOUR YEAR-OLD CHILDREN. THE HEAD START PROGRAM IS FUNDED BY THE U.S. DEPARTMENT OF HEALTH AND
HUMAN SERVICES; THE DAYCARE PROGRAM PROVIDES SUPPLEMENTAL DAYCARE SERVICES FOR CHILDREN
PARTICIPATING IN HEAD START CLASSES AND IS FUNDED BY THE STATE OF KENTUCKY AND PRIVATELY BY
INDIVIDUALS USING THE SERVICES. ADDITIONALLY, NKCAC OPERATES AN EARLY HEAD START CHILD CARE
PARTNERSHIP THAT INCLUDES FIVE COMMUNITY CHILD CARE PROVIDERS WHO SUPPLY DAYCARE FOR INFANTS AND
TODDLERS. THE USDA CHILD CARE FOOD PROGRAM SUPPLEMENTS THE FEEDING OF THE CHILDREN IN THE HEAD
